# Past Work

## Case Study 1

### **Enhanced Financial Portfolio Optimization using DRL and GAN, Reinforcement Learning, GAN**

- Optimized a financial portfolio of 20 stocks over a decade of stock price data obtained from yfinance using Advantage Actor Critic (A2C) and DDPG Deep Reinforcement Learning Agents
- Synthesized stock price data using GAN for each individual stock and retrained DRL agents on synthetic data which gave 10% better returns than training on real data

## Case Study 2

### **Efficient aggregation method in Federated Learning for Non-IID data, Federated Learning**

- Created and tested a modified version of FedAvg which also takes into account the number of labels
- Achieved 10% faster convergence than FedAvg, FedProx, Ditto over 100 rounds

## Case Study 3

### **Music Genre Classification, Machine Learning Algorithms**

- Employed various Decision Tree Based Classifiers (Random Forest, KNN, SVM, Decision Trees, XGBoost, and Gradient Boosting) to analyze GTZAN dataset, pre-processed using FFT and Mel Scale, and compared their performance in classifying music genre


